

OUR VISION

TO HAVE 700 ACTIVE VENTURERS PARTICIPATING IN THE VENTURER PROGRAM BY 2025

WHERE WE ARE NOW

SA Branch currently has approx 450 registered Venturers.
Our target of 700 Venturers means we need to have 250 more Venturers by 2025.

The Venturer section as at March 2019 currently consists of:

- 49 Registered Venturer Units
- 3 Completely empty legacy Units
- 6 Units with less than 5 Youth Members
- 22 Units with between 5 and 10 Youth Members

Responsibility for the management of Venturer membership is that of the Group Leader (as with all membership)

Youth Members remain registered as Scouts or Venturers above the age range of that section.

Scout section numbers include Youth Members who are technically 'too old' to be registered Scouts. This is mainly due to scouts leaving and Groups not removing them.

A perception/ reasoning for this may be that Groups with low numbers will be scrutinised closer by Branch.

Scouts typically becoming disengaged around this age if they are not looking to complete their Green Cord/ ASM.

Scouts are also held onto by SL's who have failed to forward plan for the eventual advancement of their Senior Scouts / PLs / TL's.

There is a perception that every Group needs to have a Venturer Unit as the Scouts don't want to leave the Group.

To date the majority of these claims have been adult voices rather than youth ones. Youth can stay affilliated with the Group in a Youth Helper capacity if they wish.

Its better to 'lose' a Scout to a local Venturer Unit than lose them for good.

PLAN TO ACHIEVE OUR VISION

700 Venturers means 35 Venturer Units in the state with at least 20 members in them. This is a target that is achievable in the future, but we must have a clear understanding of where we are starting.

In 2025 we want to see strong, active Venturer Units with over 10 members meeting regularly, working in project patrols and providing valuable life skills and lessons to our young people, supported by Adults.

Each Unit is supported in their program journey by a range of program experts. This support is provided because we know where Units are, how their program looks and how to best support them...An active dialogue and discussion helps this partnership to grow.





THE FUTURE...

A number of Groups have strong Scout numbers but no Venturer Unit - and are looking at opportunities for Venturers.

For a few terms their older Scouts link in with Venturer activities happening in other Units.

The Group has a Group plan to recruit Venturer Leaders in order to start offering Venturers at their own Group in 6 months.

They work with the Branch Venturer team to turn this dream into a reality.
